Purpose of the Manual

The purpose of this manual is to provide guidance to LeadingAge California skilled nursing facility communities about those changes, situations or plans about which the skilled nursing facility community are required to report, or to seek prior approval from, the California Department of Public Health, Licensing and Certification Program (CDPH/L&C).

Understanding these requirements will help ensure that the skilled nursing facility is in compliance with federal and state laws and regulations, and will strengthen positive communication with the CDPH/L&C.

Skilled nursing facilities may have (or are required to have) policies and procedures to address many of these notification or prior approval requirements. This manual provides information on the minimum expectations of the department, and can be used to augment other more specific policies and procedures.

How this Manual is organized

The manual is divided into two major sections: Section 1.0 - Prior Approval Required; and Section 2.0 - Notification/Reporting Requirements.

Each individual requirement has its own section with the following information:

- · Description of requirement
- Explanation of requirement
- Statutory or regulatory text of requirement
- Suggested checklist for reporting
- Links to related All-Facilities Letters or Survey and Certification Letters (if applicable).

Please note: Only AFLs from 2005 to date are included in this manual. Only S&C Letters from 2001 to day are included in this Manual.

Federal or State laws and regulations, as well as guidance about those requirements, may change frequently. This manual also provides links to reference sites and other resources that may be helpful in maintaining compliance with the most current requirements.
